€60 Stipend Bonus & Double Stipend Giveaway

Terms & Conditions for the €60 stipend bonus and the double stipend giveaway.

1. Eligibility

- 1.1 The stipend bonus and the double stipend giveaway ("Giveaway") are open to students who are aged between 16+ and are legal residents in Malta.
 - 1.2 Participants must be enrolled in a local educational institution and must receive their stipend into a Moneybase account to be eligible.
 - 1.3 Employees of Moneybase are eligible for the €60 stipend bonus.
 - 1.4 Students receiving their stipend for the first time on Moneybase are eligible for the €60 stipend bonus. If you have already received a stipend in your Moneybase account, you will not be eligible for the €60 bonus.
 - 1.5 All students except for Moneybase employees receiving their stipend on Moneybase will be eligible for the double stipend giveaway.

2. How to Enter

- 2.1 To enter, participants must:
 - Download the Moneybase App, available on iOS and Android.
 - Set up your account and complete the identity verification process.
 - Use the Moneybase MT IBAN to apply for the Maintenance Grant.
- 2.2 Entries for the stipend bonus are valid only when the participant receives their first stipend into their Moneybase account.

- 2.3** For the double stipend to be received monthly, the student must keep receiving his/her stipend into the Moneybase account every month.

3. Giveaway Details

- 3.1** Two winners will be selected randomly from eligible participants.
- 3.2** The double stipend giveaway will be calculated based on the minimum amount of stipend students can receive (€135.93).
- 3.3** The double stipend will be automatically credited into the winner's Moneybase account on the last Friday of every month.
- 3.4** Since the first stipend in December accounts for 2 months, winners will receive 2 double stipends as well.
- 3.5** The double stipend will apply every month stipend is credited into the winner's Moneybase account until August 2027.

4. Winner Selection and Notification

- 4.1** Winners will be announced on the 11th December 2026.
- 4.2** Winners will be contacted via the contact details provided in their Moneybase account and shared on social media.

5. Publicity

- 5.1** Winners must agree to have their photo taken and posted on Moneybase's social media platforms. Winners will not be tagged in these posts.

6. General Conditions

- 6.1** Participants agree to comply with all applicable laws and regulations.

- 6.2 Moneybase reserves the right to disqualify any participant who violates these Terms and Conditions of the giveaway, Moneybase app or tampers with the entry process.
 - 6.3 Moneybase is not responsible for any technical issues or errors related to the participation in the Giveaway.
 - 6.4 By participating, entrants agree to these Terms and Conditions and the decisions of Moneybase, which are final and binding.
